In January, our branch highlighted the achievements and contributions of women who history has largely forgotten in an excellent presentation by local historian, Mary Lipsey. Her book is *Almost Forgotten Women: Yesterday's Headliners*.

In February we continued the theme through a panel discussion of our September speaker, Elisabeth Griffith's book, *Formidable*. George Mason University professor, Jennifer Ritterhouse led the group discussion. Dr. Ritterhouse teaches courses centering on the American South as well as women's history.

"At present, Dr. Ritterhouse is researching the activism and spiritual and intellectual life of Lucy Randolph Mason, who was a great-great-granddaughter of George Mason IV and is best-known for her work for the Congress of Industrial Organizations (CIO) from 1937-1952. She was also a Virginia suffragist and racial liberal whose long career illuminates the shifting currents from Progressive Era reform, through New Deal liberalism, and beyond to efforts for fundamental social change." She led us through a discussion of changing gender norms for both white and black women as articulated in Griffith's book. It was an excellent program.

It brought to mind my own great-grandmother, born in 1874, who managed to attend two years of college (I believe it was Sam Houston Normal School, one of the first teaching colleges for women in the United States) and who was a teacher for a short time until she married in 1895. There were very strict rules for women teachers. Married women were not allowed to teach. They also couldn't drink or smoke or dye their hair or cut it short. They could only be seen in the company of a young man to go to church on Sundays. They were not allowed to be suffragettes. They were expected to be very prim and proper, in short, they defined the idea we have of the "school marm." She and my great-grandfather had seven children – five girls and two boys, and she survived until the age of 92. After she was widowed in 1939, she ran a boarding house to support herself and her family until she was in her late 80s. All seven of her children graduated from high school and half of them went on to higher education in a time when that was still far from the norm. I honor her and other female members of my family who not only survived, but thrived in very trying times.

AAUW has always supported women's educational success and many of our grants and lobby efforts support the opening of academic opportunities for women. By doing so, we are creating pathways for women to use their talents and abilities for the betterment of all of us.

We are, as a society, making some slow progress towards equality and improvements for people in all AAUW of Virginia will hold its annual State Conference in Williamsburg on March 18 with speakers who are modern day women of note.

Public Policy

The General Assembly (GA) session concluded on February 25 without agreement on the state budget. The House and Senate joint budget conference committee will have to continue its work. The GA will also reconvene on April 12 for the "Veto Session" to deal with any vetoes by Governor Youngkin of the legislation it managed to pass.

This short session of the Virginia legislature saw deep partisan divides. With the Republicans in control of the House of Delegates and the Democrats in control of the Senate, the votes continued a trend of lawmakers of both parties opposing each other's controversial legislation and killing them in committee

hearings. Disposing of the most controversial bills without a floor vote of the entire chamber enabled politicians to avoid going on the record in a way that could haunt them in the 2023 election.

Here is a summary of the outcomes in our key legislative and policy priorities:

Education

- The bills AAUW-VA we were concerned about that would have diverted state education funding of public schools into so-called "savings" (voucher) accounts died in committee and did not receive a general vote.
- Two bills that would have restricted transgender students' participation in school athletics and required officials to notify parents if their child identifies as trans in school were defeated in the Senate. Supporters said the bills would have promoted fairness for female athletes and protected parental rights, and the measures cleared the floor of the Republican-controlled House of Delegates means that no legislation on school accommodations or health care for trans children will reach Gov. Youngkin's desk.
- A Senate committee killed multiple bills from the House that aimed to increase parental oversight in public schools. Bills defeated by the Senate Education and Health Committee included proposals to require that parents be notified and allowed to opt their children out of presentations or performances by outside groups and mandate parental involvement in the crafting of library policies.
- AAUW-VA will continue as a member of the Fund Our Schools coalition which we joined this year. The coalition gives us additional resources to advocate for public school funding, one of our top legislative priorities. We ask that you use their portal https://www.fundourschoolsva.org/fundour-schools-in-the-state-budget/ to ask lawmakers to ensure that public schools are fully funded in the ongoing budget talks that now continue after the conclusion of the GA session.

Reproductive Rights and Abortion

- All the abortion bans were buried or defeated prior to crossover, but there were still some harmful anti-abortion bills that did move to the State Senate. The Senate Education and Health Committee defeated two that stigmatized health care. Delegate Greenhalgh's bill would have interfered in the patient-provider relationship by reinstating medically unnecessary biased counseling for abortion patients, and Delegate Freitas's bill threatened to criminalize health care providers.
- A bill that would have mandated that the Virginia Department of Health list crisis pregnancy centers on its website was defeated in the Senate Rules Committee. Crisis pregnancy centers are fake health care centers that mislead pregnant people, and the American Medical Association has called them "unethical."
- Unfortunately, the constitutional amendment that would allow voters to enshrine a right to reproductive freedom in our constitution was defeated in the House Courts of Justice Subcommittee 1. This subcommittee had considered the House of Delegates version of this legislation and rejected it previously. The State Senate version had passed on the State Senate floor on a vote of 21-18.
- A bill that would have protected online menstrual tracker data from subpoenas was defeated in the House, along with the Contraceptive Equity Act, which would have required health care insurers to provide coverage for contraceptives.

Workplace Rights

- Efforts to expand Paid Family & Medical Leave and Paid Sick Leave were defeated in House committees.
- Both a salary history ban bill and a mandate for workplace harassment training were defeated in House committee.
- One bright spot was passage of the "Silence No More Act" would prohibit non-disclosure and non-disparagement provisions in employment contracts or settlement agreements if the contracts were to bar discussion of conduct at a past workplace, at work events, and between employees and employers.

Voting Rights

• On February 17, the Virginia Senate passed HB1948 (Bloxom), which the House passed unanimously on February 2, removing the witness requirement for absentee ballots beginning July 1, 2023. Instead, voters will be required to provide the last four digits of their social security number along with their date of birth and signature.

Electronic Meetings

• A bill to expand electronic meetings was tabled in the House.

Virginia made history this month with the election of its first Black woman to the U.S. Congress, Jennifer McClellan. A copy of our letter of congratulations to her is attached.

We again express our thanks to those of you who were able to participate in Lobby Day or took other action to reach out to your legislators. We hope to see many of you at the AAUW-VA conference this month.

2023 is going to be a very active election year in Virginia with the entire General Assembly up for election. At our next Public Policy meeting on March 30, we will discuss how we can inform our members and other voters about candidate positions on our Public Policy priorities.




Evening Book Group - Virtual



March is Women's History Month!

Did you know:

- Sixty-three percent of women voted in the 2020 presidential election, compared to 59.5% of men. Women have voted at a higher rate than men in presidential elections since the 1980s.
- Since 1916, every state but Vermont has sent a woman to the US Congress, until 2022 when Democrat Becca Balint won the race for Vermont's lone seat in the U.S. House, becoming the first woman and first openly gay person to represent the state in Congress.
- Since 1980, there have been more females than males in the US. The female population grew 6.3% in the last 10 years.
