Public Policy

Virginia State Senator Dave Marsden is critically important for passing a paid sick day standard in Virginia's General Assembly. Senator Marsden is a senior member of the Senate Commerce and Labor Committee, which means that his view will be particularly important. Two years ago in subcommittee, Senator Marsden made a speech about the importance of part-time working people being covered by the paid sick day bill. This year, when there is a real possibility of passing a standard, the opponents will seek to reduce coverage of the bill by exempting small businesses and part-time working people. Senator Marsden will face fierce lobbying by those who will try to exempt as many employers and working people as possible.

Virginia State Senator Scott Surovell is the patron of a bill to pass a paid sick day standard, but as the incoming Senate Majority Leader, he is under enormous pressure to weaken the bill – both from hard core opponents and from squishy members of his party who will want to pretend they support paid sick days, but will try to exempt people from being covered by the bill. We need to support Senator Surovell in passing a strong paid sick day bill.

As a member of the Virginians for Paid Sick Days Coalition, AAUW-VA is advocating a standard requiring every employer to allow working people to accrue up to five paid sick days – something more than 40 percent of Virginia working people don't currently have. Too many working people who stock our grocery shelves, look after our elders, care for the sick, and provide childcare are without any paid sick days or PTO.

But even this modest standard of five days will be a fight. Opponents will seek to exempt small businesses – the ones least likely to have paid sick days – and part-time working people. Most states that have passed a paid sick day standard cover all working people, including part-time working people, because all working people get sick. If viruses and colds impact everyone, then all working people need access to a few paid sick days, regardless of the size of their employer or their part- or full-time schedule.

Help Virginia pass a paid sick day standard. And, help make sure the bill covers all working people, including part-time folks. Use the appropriate message listed here or call to urge his support for a paid sick day standard that covers everyone.

Please use your leadership to pass a paid sick day bill that covers all workers. Everyone deserves a few paid sick days.

- 2017 **AAUW** engaged in the White House Task Force to Protect Students from Sexual Assault.

The LWV of Virginia presents a virtual special screening of the documentary: "Invisible Warriors: African American Women and World War II" March 20, 7:00 P.M.


